3 Because the prior motions and Yahoo!'s renewed motion, in which Facebook now joins,
4 have been fully briefed and because the Court has scheduled oral argument on Yahoo!'s renewed
5 motion and the Renewed Motion to Sever or Dismiss filed by eBay, Netflix, Office Depot, and
6 Staples (Dkt. No. 192), Facebook requests that its joinder in Yahoo!'s renewed motion be
7 considered along with the other motions to dismiss or sever. In filing this notice Facebook does
8 not request additional time for argument at the April 25, 2011 hearing, and will coordinate with
9 the other defendants on use of the allotted time.

10 Counsel for Facebook met and conferred telephonically with counsel for Plaintiff on April
11 8, 2011, and, subject to the Court's approval, Plaintiff's counsel has consented to Facebook's
12 filing of this notice joining Yahoo!'s renewed motion and Facebook's request for oral argument
13 on April 25, 2011.
