**STIPULATED MOTION TO
SERVE AMENDED
INFRINGEMENT CONTENTIONS**

JURY DEMAND

Plaintiff Interval Licensing LLC (“Interval”) and defendant YouTube LLC. respectfully move under Local Patent Rule 124 for an order authorizing Interval to serve amended infringement contentions on YouTube.

Consistent with the Court’s scheduling order, Interval served infringement contentions on all defendants on December 28, 2010. Subsequently, counsel for Interval and for YouTube held a meet and confer session and exchanged emails addressing a number of concerns that YouTube raised about the infringement contentions. Interval prepared and informally served a copy of proposed infringement contentions February 10, 2011. Both Interval and YouTube now agree that these February 10, 2011 amended contentions should supersede the contentions served in December.

1 Local Patent Rule 124 requires leave of Court to serve amended infringement
2 contentions after the deadline established in the scheduling order. Interval therefore
3 respectfully requests that the Court enter an Order authorizing service of these
4 amended infringement contentions as of the date of this motion. YouTube has no
5 objection and joins in this motion.
