**SAMSUNG'S COMMENT ON REVISED
FINAL JURY INSTRUCTIONS**

1 Samsung hereby submits this comment in response to the Revised Final Jury Instructions
2 filed by the Court this evening. (Dkt. No. 1883.)

- 3 • Instruction No. 45 abbreviates the names of the Samsung entities, SEC, STA and
- 4 SEA. Because all other instructions spell out the full names of these entities,
- 5 Samsung believes that Instruction No. 45 should do so as well, to avoid confusion.
- 6 • Instruction No. 47 omits the word “is.” This instruction should read “Samsung
- 7 denies that it infringed Apple’s asserted iPad-related trade dress and, as already
- 8 stated, contends it is unprotectable.”
- 9 • Apple’s comment #7 is substantive, not just typographical.
