1 Pursuant to Civil L.R. 6-2, Apple Inc. (“Apple”) and Samsung Electronics Co., Ltd.,  
2 Samsung Electronics America, Inc., and Samsung Telecommunications America, LLC  
3 (collectively “Samsung”) file this Stipulation regarding the schedule for briefing Apple’s Motion  
4 to Compel Depositions of Samsung Declarants.

5 WHEREAS, the Court entered an Order re: Post-Trial Proceedings (Dkt. No. 1945);

6 WHEREAS, Samsung filed certain expert declarations in connection with its opposition to  
7 Apple’s motion for a permanent injunction and/or Apple’s motion for judgment as a matter of law  
8 on October 19, 2012 (Dkt. Nos. 2054-1, 2054-2, 2054-3, 2054-4, 2054-5, 2057, 2059);

9 WHEREAS, Apple is filing a motion on October 23, 2012 contemporaneous with this  
10 stipulation, seeking an order compelling the deposition of four of these experts by November 2,  
11 2012;

12 WHEREAS, the parties have agreed to a shortened schedule to brief Apple’s motion;

13 NOW THEREFORE, IT IS HEREBY STIPULATED and agreed to by and between the  
14 parties that:

- 15 1. Samsung shall file an opposition to Apple’s motion to compel by 6:00 p.m. on  
16 October 26, 2012;
  - 17 2. Apple shall not file a reply brief; and
  - 18 3. The parties waive oral argument.
