18	On August 28, 2012, this Court filed an Order setting out the schedule for post-trial		
19 20	briefing. ECF No. 1945. In that Order, the Court stated that the "page limits set forth herein will		
20 21	be strictly enforced. Any argument that is not explicitly articulated within the briefing page limits		
21 22	will be disregarded. Any supporting documentation shall be for corroboration purposes solely and		
22	shall not be used as a vehicle for circumventing the Court's page limits." Id. at 3.		

Despite this Order, both parties submitted a large amount of documentation with their posttrial motions, much of which was either not cited at all in the briefing, or cited in only a conclusory manner, such that the arguments contained in the supporting documentation were not articulated within the briefing page limits. The Court has not relied on any of this documentation in ruling on
