INTRODUCTION

The International Day Against Homophobia, Transphobia, and Biphobia (IDAHOBIT) is a global campaign with the goal of raising awareness regarding the discrimination, violence, and challenges experienced by the LGBTQIA+ community. Celebrated annually on 17 May, IDAHOBIT offers a platform for individuals, organisations, and governments to unite and advocate for equality and diversity.

To facilitate participation at all levels in such a relevant day for our communities worldwide, as of January 2023 ILGA World coordinates the IDAHOBIT Working Group and hosts its Secretariat.

In 2023, the focus of the IDAHOBIT campaign revolved around the theme “Together always: united in diversity.” This theme underscored the significance of solidarity, allyship, and the acknowledgment that our collective strength lies in the diverse range of identities, experiences, and backgrounds within our communities. It emphasised the need to remain together, support one another, and foster an inclusive society that respects and celebrates the rights of all individuals, regardless of their sexual orientation, gender identity, or expression.

The IDAHOBIT campaign aims at having a lasting impact by increasing awareness, facilitating dialogue, and promoting positive change at the local, national, regional, and global levels. To mark the date, individuals, communities, and groups worldwide organise various activities, events, and initiatives that celebrate LGBTQIA+ populations and advocate for equality and respect.

This annual report serves as a concise overview of the IDAHOBIT campaign’s accomplishments, impact, and moments from the year 2023. It provides insights into activities, global events, symbolic gestures, and statements issued by national and international agencies all across the world.

Let us unite in reflection, embrace the lessons learned from the challenges faced, and renew our commitment to promoting equality, acceptance, and love for all individuals, regardless of their sexual orientation, gender identity or expression, or sex characteristics.

CAMPAIGN AND IMPACT

IDAHOBIT 2023 witnessed a wide range of impactful activities and initiatives that contributed to raising awareness, promoting inclusivity, and advocating for the rights of the LGBTQIA+ community.

Campaign activities and initiatives

The campaign helped give more visibility to numerous events worldwide. These activities aimed at engaging diverse audiences, encourage dialogue, and provide educational resources on issues related to homophobia, transphobia, and biphobia.

Social media engagement and reach

Our social media platforms served as powerful tools to spread information, share stories, and encourage participation in the campaign. Through engaging content like videos and illustrations, we connected with a global audience and fostered meaningful conversations. Many individuals and organisations shared their messages, personal stories, and educational resources, amplifying the visibility of the campaign and reaching people around the world.



The hashtag **#IDAHOBIT2023** was used in over 35,000 tweets, and **#IDAHOBIT** was used in over 88,000 tweets between 15 and 22 May 2023. In May, our own social media accounts had 145,862 tweet impressions on Twitter, reached 24,386 accounts on Facebook, and 15,654 accounts on Instagram. We also experienced a remarkable growth in engagement, with a 510% increase on Instagram and a 495% increase on Facebook. At the end of May, our Facebook page had 50,859 followers, Twitter 11,264 followers, and Instagram 2,055 followers.

Use of campaign illustrations and theme

The theme “Together always: united in diversity” was part of the many statements released by UN and regional agencies, governments, universities, and non-profit organisations.

The official campaign illustrations played a significant role in capturing our message’s essence. These illustrations, by Chilean artist Sofía Miranda Van den Bosch, depict people holding a thread that represents connection and togetherness across movements, populations, and identities, which is part of the theme of this year’s IDAHOBIT, “Together Always: United in Diversity.” The diversity of our communities is beautifully captured, with each image showing the world from a different angle on an abstract background that gives an air of magic and hope.

The illustrations were widely shared and used by individuals, organisations, and institutions to raise awareness about the campaign and show solidarity with the LGBTQIA+ community. They provided a vibrant and visually striking representation of our collective commitment to embracing and celebrating the beautiful diversity within the LGBTQIA+ community.

The illustrations were available in 32 languages for download and use.



Video messages

The individuals featured in our twelve campaign videos brought diverse perspectives to the global IDAHOBIT campaign.

Esan Regmi, Executive Director of Campaign for Change and Co-chair of ILGA Asia, underscored the significance of solidarity in the fight for intersex rights. **Erika Castellanos**, Executive Director at GATE, highlighted the importance of active solidarity between social justice movements to dismantle systems of oppression. **Ymania Brown** and **Luz Elena Aranda**, Co-Secretaries General of ILGA World, emphasised the importance of collaboration and forming alliances with other movements fighting for justice and equality to amplify our collective impact. **Farah Abdi**, Policy Officer of TGEU, spoke about the power of intersectional activism in creating a better

world for all. **Franco Fuica**, Public Policy Advisor at OTD Chile, stressed the importance of visibility and commemoration of significant dates like the International Day against Homophobia, Transphobia, and Biphobia.

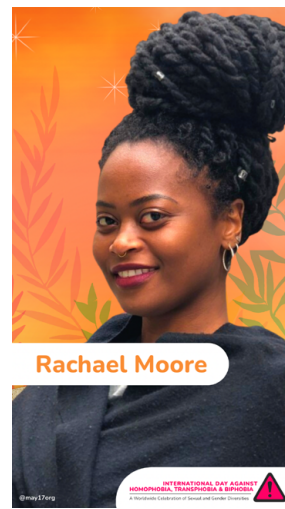
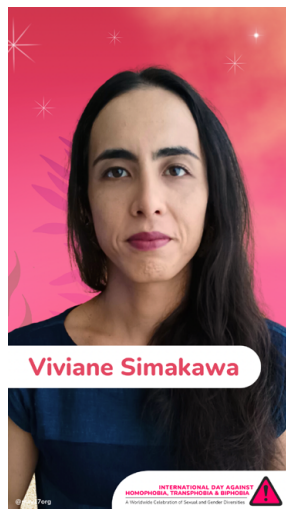
Alexa Santos, Board member of EL*C, raised awareness about the dangers of lesbophobia and the necessity of ensuring that lesbians are not left behind. **Jeremy Gobin**, Communications Officer at IGLYO, called for the inclusion of young voices to safeguard the progress we have made. **Nhuun Wannapong Yodmuang**, Senior Human Rights and Advocacy Officer at APTN, reminded us that discrimination and violence against trans people exist globally, but they manifest differently in various cultures and contexts.

Tashnuva Anan, Chair of the Trans Steering Committee of ILGA World, highlighted the role of visibility in breaking down stereotypes and driving social and political change for the trans community.

Rachael Moore, co-founder of Rainbow Nation Brussels, emphasised the increasing number of bisexual individuals coming out, demanding inclusion, and advocating for representation. **Midnight Poonkasetwattana**, Executive Director of APCOM, mentioned

the celebration of the 75th anniversary of the Universal Declaration of Human Rights in 2023 as an opportunity for us to unite as a global community and showcase our strength. **Viviane Vergueiro Simakawa**, Program Officer at the International Trans Fund, highlighted the importance of directing funding and resources to where they are most needed.

These video messages from key voices of LGBTQIA+ advocates underscored the importance of collaboration and inclusivity in achieving equality and justice. Their contributions, along with others, showcased the importance of unity, visibility, intersectionality, and collaboration in driving positive change for LGBTQIA+ individuals worldwide.

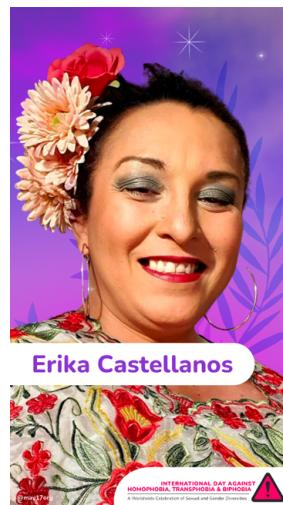
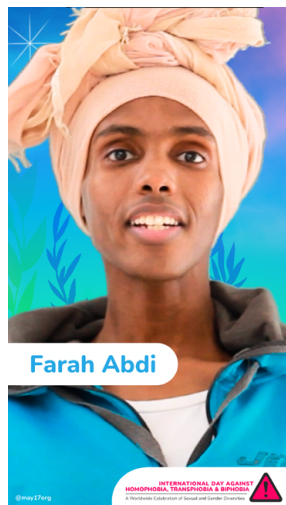


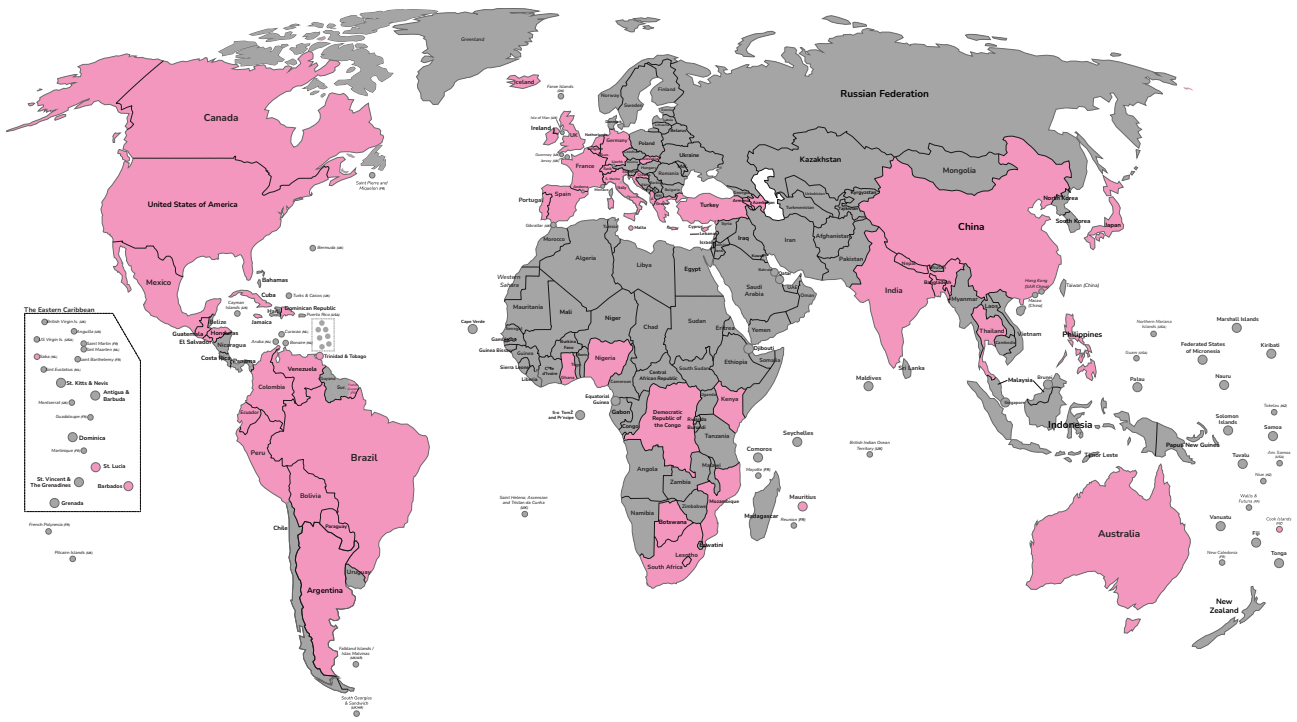
EVENTS

In the following sections, we will explore some events and initiatives organised by civil society organisations, individuals, human rights bodies, embassies and institutions from across the globe. Additionally, we will showcase a photo album capturing the vibrant displays of solidarity through rainbow flags and lights in iconic landmarks. Lastly, we will highlight powerful statements issued by international agencies, including the United Nations, the European Commission, and various national and regional bodies.

Events around this year's IDAHOBIT happened in at least 56 countries and territories.¹ From all corners of the globe, communities have come together to organise a wide range of activities such as panel discussions, workshops, film screenings, art exhibitions, and virtual rallies.

- **Panel discussions, workshops, and conferences** addressed the unique challenges faced by LGBTQIA+ communities, promoted dialogue, fostered solidarity, and raised awareness.
- **Human rights conferences and seminars** tackled crucial topics such as legal advancements, healthcare access, and LGBTQIA+ inclusion in public policy.
- **Research projects** focused on the human rights of LGBTQIA+ people released valuable data and findings, providing important insights into different regions and contributing to the body of knowledge on LGBTQIA+ issues.
- **Artistic performances** played a vital role in amplifying queer narratives and challenging societal norms. Theatre plays, musicals, poetry readings, drag shows,

and film screenings provided a platform for creative expression and sparked conversations.

- **Awareness campaigns** in schools, universities, and workplaces played a pivotal role in combating discrimination and creating inclusive environments. These campaigns aimed to educate and foster acceptance.
- **Collaborations between governments, embassies, and civil society** showcased support for the rights of LGBTQIA+ persons. Rainbow flags and lighting landmarks in rainbow colours symbolised solidarity and demonstrated the collective effort to promote equality.

As we look back at this year's IDAHOBIT, it is essential to recognise the invaluable contributions of individuals, organisations, and allies. Their dedication, resources, and voices have been instrumental in driving positive change and fostering a culture of acceptance and equality.

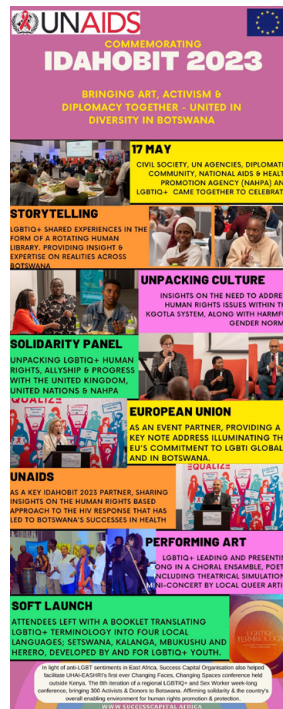

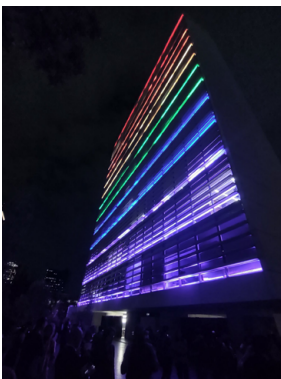

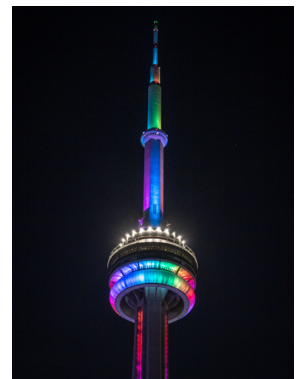
