



## Maklumat Apple Watch

### Panduan Pengguna Apple Watch

Semak semula Panduan Pengguna Apple Watch sebelum menggunakan Apple Watch. Pergi ke [help.apple.com/watch](http://help.apple.com/watch), muat turun versi ePub daripada Kedi eBooks (di mana tersedia), atau buka app > Perihal > Lihat dan ketik Jam Saya, kemudian pergi ke Umum > Perihal > Lihat Panduan Pengguna Apple Watch. Kekalkan dokumentasi untuk rujukan masa depan.

### Keselamatan dan Pengendalian

Lihat "Keselamatan, Pengendalian, dan Sokongan" di Panduan Pengguna Apple Watch. Apple Watch, sesetengah talinya, dan Kabel Pengecasp Magnetik Apple Watch mengandungi magnet. Apple Watch, pengesan kadar jantung, dan app Apple Watch yang dimasukkan adalah bukan peranti perubahan dan bukan dimaksudkan untuk tujuan kecerdasan sahaja.

### Pendedahan kepada Tenaga Frekuensi Radio

Untuk maklumat pendedahan frekuensi radio untuk Apple Watch, buka aplikasi Apple Watch di iPhone dan ketik Jam Saya, kemudian pergi ke Umum > Perihal > Sah > Pendedahan RF. Atau pergi ke [www.apple.com/legal/rfexposure](http://www.apple.com/legal/rfexposure).

### Bateri

Bateri litium-ion dalam Apple Watch perlu diservis oleh Apple atau pembekal perkhidmatan yang sah. Anda mungkin menerima gantian Apple Watch apabila membuat servis bateri. ### Ringkasan Waranti Terhadap Satu Tahun Apple
