INSTRUCTIONS FOR LIST OF PROSPECTIVE GUN SHOW VENDORS OFFERING FIREARMS OR AMMUNITION FOR SALE OR DISPLAY

The List of Prospective Gun Show Vendors Offering Firearms or Ammunition for Sale or Display (BOF 105) must be completed and signed by the licensed gun show producer. Use as many List of Prospective Gun Show Vendors Offering Firearms or Ammunition for Sale or Display forms as required to list all participating vendors for the gun show or event being reported.

The gun show producer shall also submit no later than fifteen (15) days prior to the gun show or event a revised Annual Event and Security Plan form (BOF 104) if significant changes have been made since the original Annual Event and Security Plan form (BOF 104) was submitted.
