Collection of your Personal Information

Information about your computer hardware and software may be automatically collected by AquaLayer. AquaLayer may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to AquaLayer, and they are required to maintain the confidentiality of your information.

AquaLayer will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on AquaLayer or the site; (b) protect and defend the

rights or property of AquaLayer; and, (c) act under exigent circumstances to protect the personal safety of users of AquaLayer, or the public.

Use of Cookies

The AquaLayer website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page.
