LETTER FROM COLONEL JOHN BOLDOC

Dear Friends,

This biannual report represents just a snapshot of the outstanding work done over the last 24 months by the dedicated sworn and civilian staff of the Nebraska State Patrol. I hope you will take the time to look over this report and notice that behind every photograph and statistic, there is a story of public servants doing their best to safeguard Nebraska. I would like to thank each member of the Nebraska State Patrol team for their exemplary work in serving, protecting, and diligently carrying out their duties.

Early in 2018 the Nebraska State Patrol adopted a short term strategic plan to establish agency goals for the following three years. Strategic restructuring, adopting new technologies, creating a wellness program for officers and civilian staff, and identifying mission focus were some of the 11 goals. Thanks to the hard work and support of each team member, we have already achieved 7 of the 11 strategic goals.

Carrying out the planned work of the agency is important, but responding to unplanned emergencies is where our Troopers and Civilian Staff consistently display their skills and dedication. The unprecedented floods of 2019 interrupted the lives of our neighbors and friends across the state. Troopers, Dispatchers, and Support Staff stepped up to rescue over 160 people from flood waters, and served countless others in stressful circumstances as these natural disasters lasted for months. I am so thankful for the bravery and diligence demonstrated by your NSP Team.

Another tragedy struck Nebraska on June 20, 2019 when Trooper Jerry Smith Jr. was killed by a careless driver in a traffic crash in Morrill County. Trooper Smith was the first line of duty death in 20 years. Trooper Smith will be remembered as a devoted public servant and family man who was simply doing his job when he was killed that summer morning.

As we reflect on the accomplishments of the Nebraska State Patrol over the last two years, it is important to acknowledge the support of the community and our state leaders. Without the support of our citizens, Governor Pete Ricketts, and the members of the Legislature, our difficult task of serving Nebraska would not be possible. Thank you for partnering with us.

NEBRASKA STATE PATROL

The Nebraska State Patrol is a full-service law enforcement organization which has been serving Nebraska since 1937. The agency's Mission Statement is emblematic of both our civilian and sworn employees: " The Nebraska State Patrol shall provide law enforcement of the highest quality to ensure a safe and secure Nebraska- Pro Bono Publico". (For the Good of the Public)

Several divisions of the agency are under the direction of the Superintendent's Office which include; The Office of Professional Standards, Human Resources, Process Improvement, and Public Relations.

The Nebraska State Patrol utilizes four majors which divide agency operational responsibilities into three distinct geographic areas as well as an Administrative Services component. The Administrative Services section is under the purview of Major Russ Stanczyk and includes the following divisions: Accounting, Grants, Information Technology, Research & Planning, Procurement, Radio Communications, Project Management, and the Criminal Identification Division. The goal of Administrative Services is to ensure all members of the organization are provided what they need to succeed so the agency can meet the expectations of our citizens.

Major Brenda Konfrst commands the Nebraska State Patrol Eastern Operations Division, comprising both Troop A, based in Omaha, and Troop B, based in Norfolk. Major Konfrst also commands NSP Special Operations, the Aviation Support Division, as well as Capitol Security.

Major Jeff Pelowski commands the Central Operations Division. Central Operations encompasses Troop H , based in Lincoln, Troop C, based in Grand Island, Carrier Enforcement Division, Training Academy and the Nebraska Information and Analysis Center (NIAC). The Central Division continues to leverage technology to place troopers where they can be most effective utilizing real time crash data and analyzing calls for service. The goal of the Central Field Services Division is to provide high visibility patrolling and enforcement to not only meet the publics expectation, but to exceed it.

Major Mike Jahnke commands the Western Operations Division. The Western Division encompasses Troop D, based in North Platte, Troop E, based in Scottsbluff, and The Nebraska State Patrol Criminalistics Laboratory, based in Lincoln. The Western Division is responsible for the largest geographic area in Nebraska, and proudly provides highly visible proactive policing in partnership with our allied agencies to ensure a safe Nebraska.

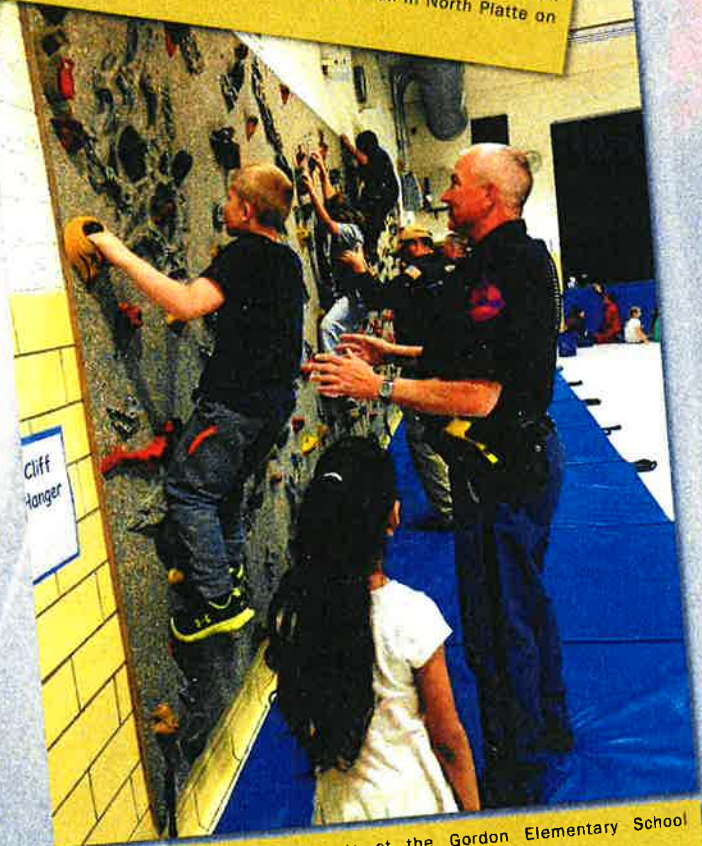

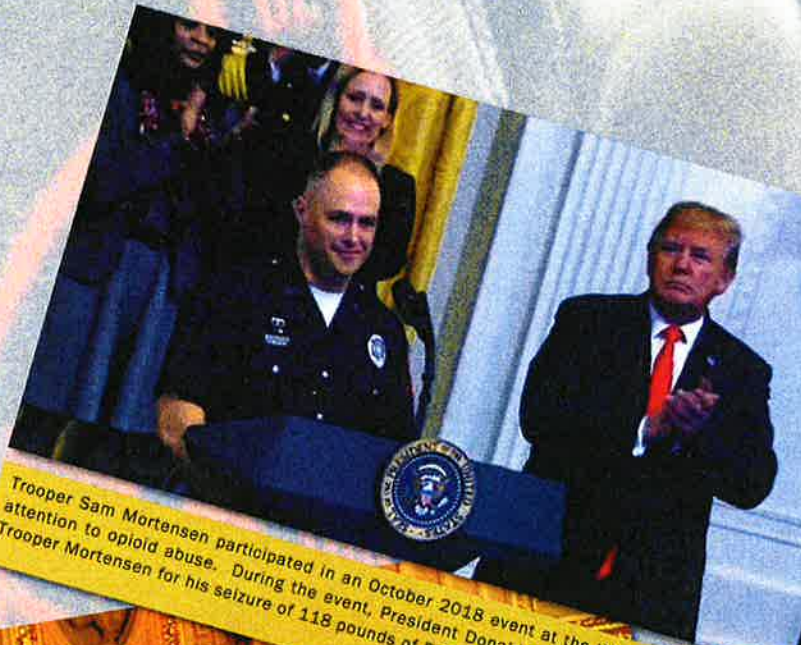

Troopers along with allied agencies assisted with evacuating hundreds of people from local hotels and businesses to shelters. Many of those businesses suffered catastrophic damage, including the Kearney NSP office.

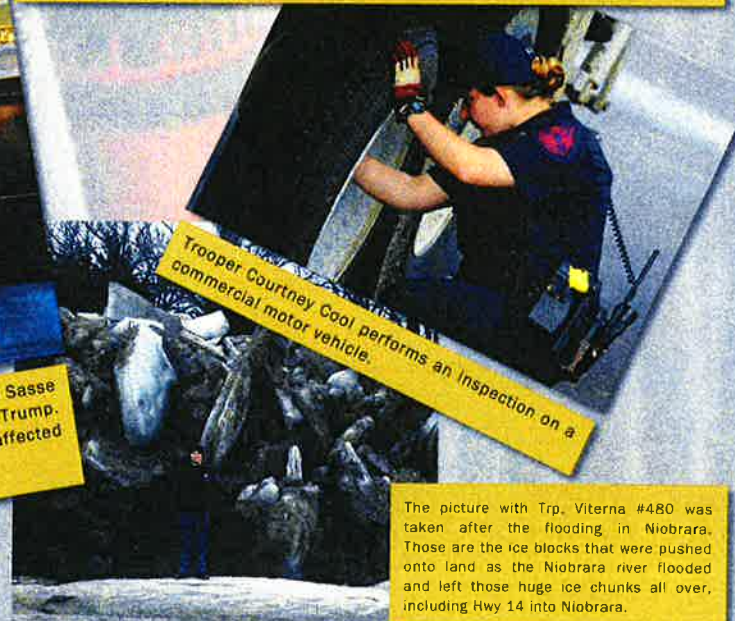

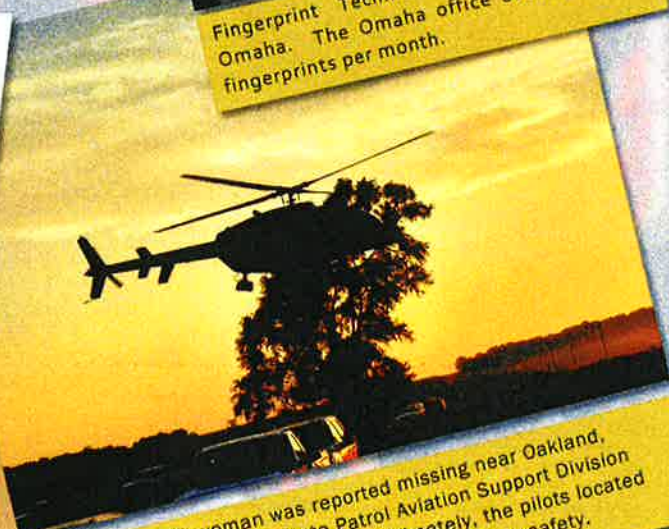
Trooper Kendall Reed #590 conducted a traffic stop on a commercial van in April 2018. With assistance from Trooper Justin Davis #13 and his K-9 J.D., probable cause was developed to search. The search yielded 1,853 pounds of marijuana, 8,779 dosage units of hashish oil cartridges, and 49 pounds of loose hashish wax and THC shatter. Subsequent investigation with DEA leads to arrests of 4 other individuals, seizure of \$124,000 in gold coins, \$2,719,000 U.S. currency, 3 Mercedes Sprinter vans, \$190,000 in attempted bond money, 2 firearms and potential additional forfeiture of assets in multiple states.



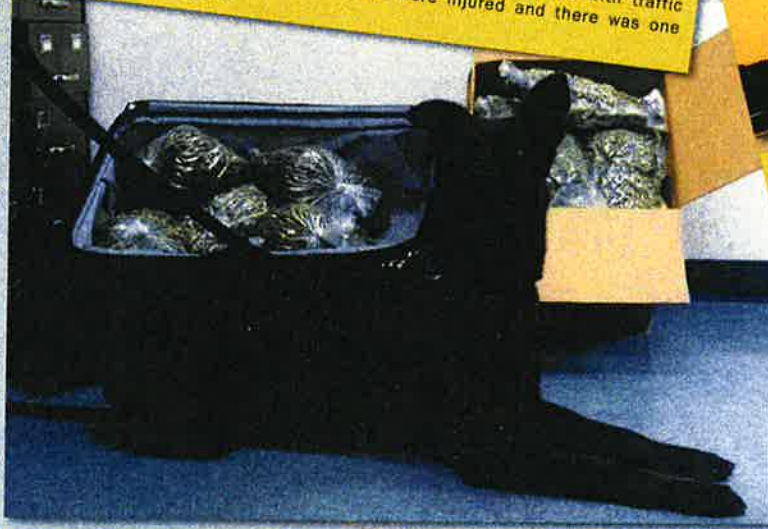
Fingerprint Technician Tiffany Carter in Omaha. The Omaha office averages 1,200 fingerprints per month.



A dust storm on April 29, 2018 in Hamilton County led to a 27 vehicle crash near mile marker 334 on I-80. Multiple NSP units were directly involved in working the crash while several other allied law enforcement agencies assisted with traffic control and the investigation. In all, 12 people were injured and there was one fatality as a result of the crash.



When an elderly woman was reported missing near Oakland, Nebraska, the Nebraska State Patrol Aviation Support Division responded to assist in the search. Ultimately, the pilots located the woman and Captain Frank Peck carried her to safety.



In 2019 the Nebraska State Patrol Service Dog Division assisted with the following calls. Over 350 Detection Calls resulting in 2,000 lbs. of Marijuana & 30 lbs. of Meth being seized.

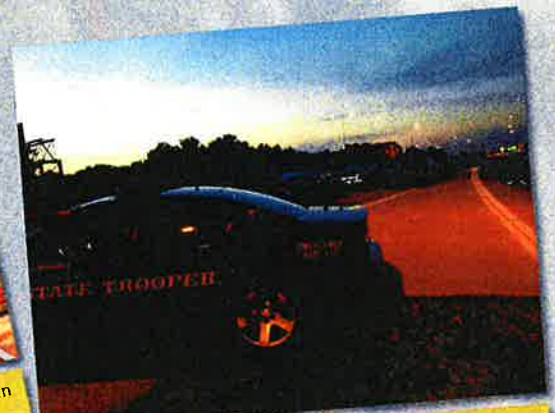
Sgt. Ben Schropfer won the Grand Champion challenge at the Commercial Vehicle Safety Alliance competition.

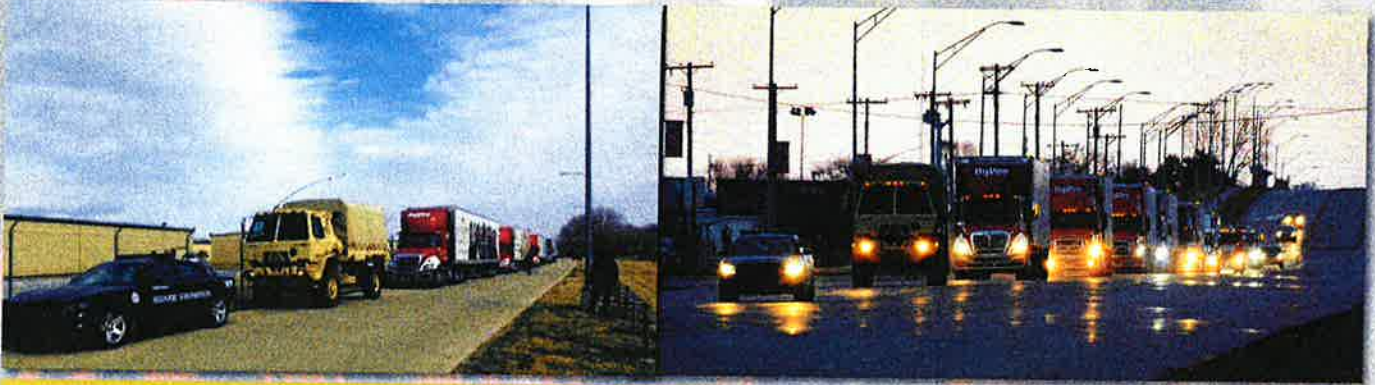

Trooper Nicholson teamed up with our Game and Parks Conservation Officers at Lake McConaughy to help patrol the large crowds over holiday weekends.



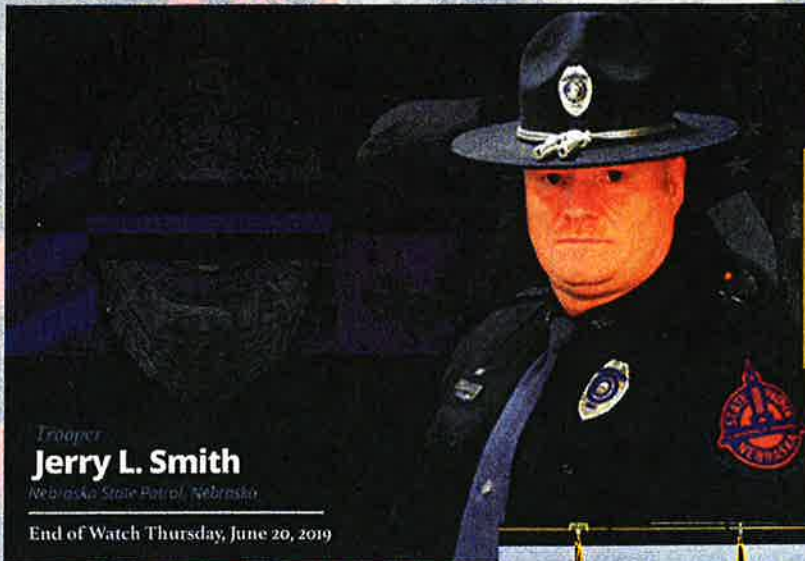
Sgt. Buhke partnered with the North Platte Police Department in a patch exchange to further awareness on breast cancer.

More than 300 people, including Gov. Pete Ricketts and law enforcement officers from around the country, attended the funeral of Trooper Smith.

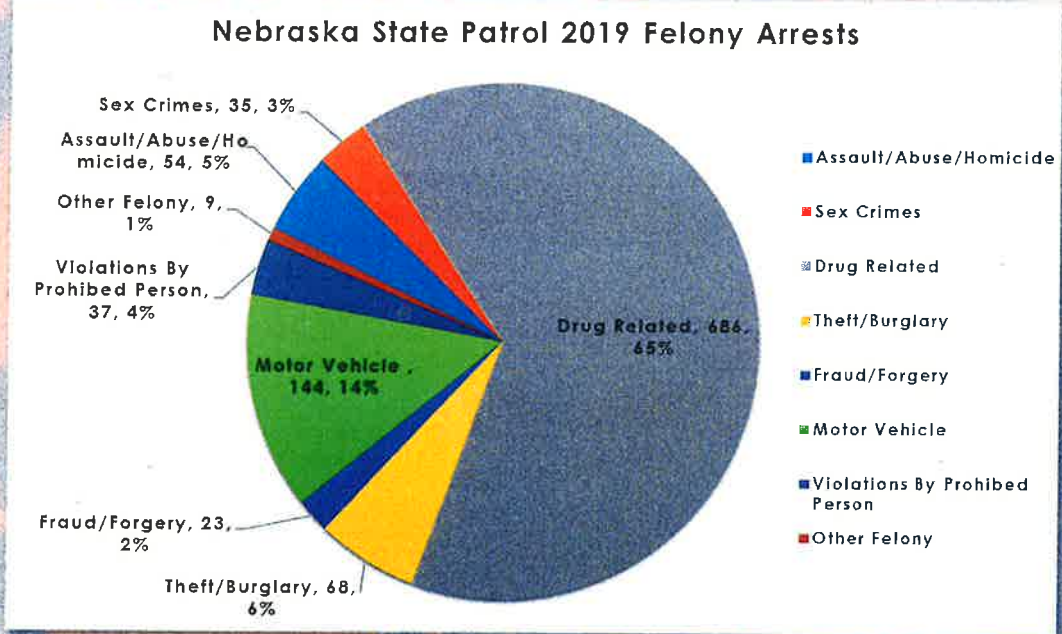

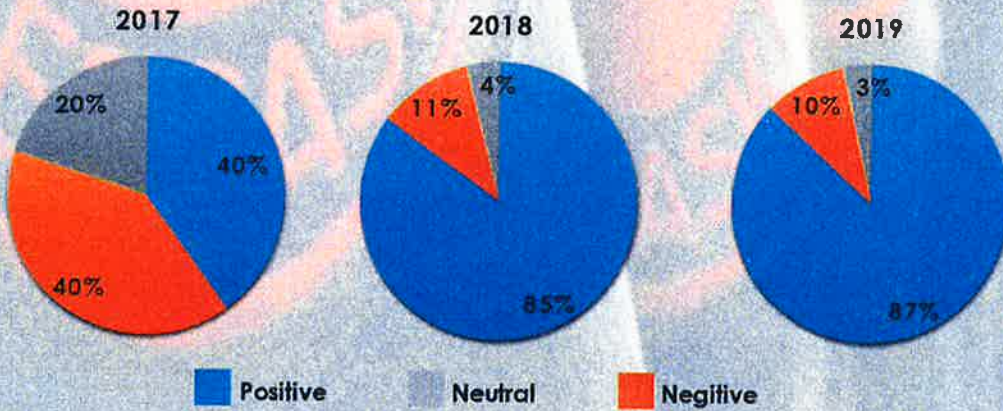

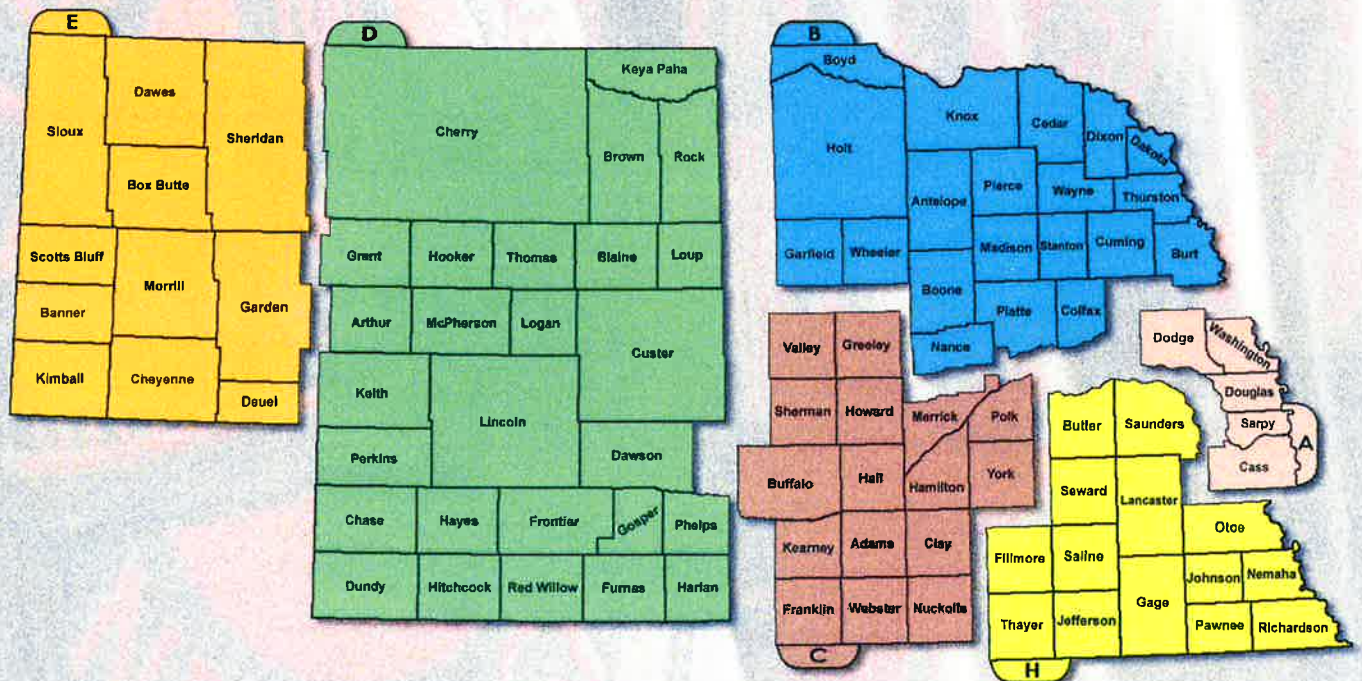
