MOZILLA RUNS EDUCATIONAL PROGRAMS TO GIVE PEOPLE SKILLS TO COMMUNICATE, BUILD AND INNOVATE USING THE OPEN TECHNOLOGY AND CULTURE OF THE WEB. IN 2013, THE FOUNDATION CONTINUED TO GROW ITS WEBMAKER DIGITAL LITERACY PROGRAM, WITH VOLUNTEERS RUNNING OVER 1600 LEARNING EVENTS IN OVER 80 COUNTRIES. MOZILLA ALSO STARTED WORK ON A MORE AMBITIOUS SET OF CURRICULUM OFFERINGS; SOFTWARE TO TEACH DIGITAL LITERACY ON SMARTPHONES; AND "OPEN BADGES" THAT RECOGNIZE THE SKILLS THAT PEOPLE HAVE LEARNED.
