

# FIND HELP PAYING FOR MEDICAL CARE

Texas has four state-wide programs aimed at providing low-income, uninsured women with access to free medical care.


 **Medicaid for Pregnant Women**

- Must be U.S. citizen\*
- Income below 198% Federal Poverty Level
- Full Medicaid benefits
- Coverage ends approximately two months after delivery\*\*

 **CHIP-Perinatal (CHIP-P)**

- No U.S. citizenship requirements
- Income below 202% Federal Poverty Level
- Coverage is for pregnancy-related services
- Prenatal visits and up to two postpartum visits

 **Healthy Texas Women (HTW)**

- Must be U.S. citizen or qualified immigrant
- Income below 200% Federal Poverty Level
- For women ages 15 - 44 years old
- See the back for more on covered services, including the HTW Plus program.

 **Family Planning Program (FPP)**

- No U.S. citizenship requirements
- Income below 250% Federal Poverty Level
- Men and women ages 64 and under are eligible
- See the back for more on covered services

Women may be eligible for one or more of these programs if they earn less than: \*\*\*

Family of 3:  
**\$4,575/month**

Family of 4:  
**\$5,520/month**

Family of 5:  
**\$6,467/month**

To enroll have these documents: Picture ID, Proof of Income (e.g. pay stub), and proof of residence (e.g. electric bill).

\* Certain lawfully present immigrants may also qualify. For more information visit your local community health center.

\*\*The 87th Texas Legislature approved the extension of Medicaid coverage to 6 months after delivery. When the extension goes into effect, this document will be updated.

\*\*\* These numbers are 250% of Federal Poverty Level in 2021, based on pre-tax earnings. [Numbers are updated annually.](#)
