INTERNATIONAL COVENANT ON CIVIL AND POLITICAL RIGHTS  
NEW YORK, 16 DECEMBER 1966

PERU: NOTIFICATION UNDER ARTICLE 4 (3)

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

The Permanent Mission of Peru to the United Nations presents its compliments to the Treaty Section of the Office of Legal Affairs, United Nations Secretariat and, in accordance with article 4 of the International Covenant on Civil and Political Rights, bearing in mind what is stated in note verbale LA 41 TR/2017/IV-4/Peru/1, dated 1 March 2017, has the honour to report the following:

- Through Supreme Decree No. 188-2020-PCM, dated 6 December 2020, the Government of Peru declared a state of emergency in the districts of Puerto Inca, Tournavista, Yuyapichis, Codo del Pozuzo and Honoria in the province of Puerto Inca in the department of Huánuco; and in the districts of Constitución, Palcazú and Puerto Bermúdez in the province of Oxapampa in the department of Pasco, for a period of 60 calendar days.
- Through Supreme Decree No. 069-2021-PCM, dated 2 April 2021, the Government of Peru declared a state of emergency in the districts of Puerto Inca, Tournavista, Yuyapichis, Codo del Pozuzo and Honoria in the province of Puerto Inca in the department of Huánuco; and in the districts of Constitución, Palcazú and Puerto Bermúdez in the province of Oxapampa in the department of Pasco, for a period of 60 calendar days starting on 6 April 2021.
- Through Supreme Decree No. 109-2021-PCM, dated 4 June 2021, the Government of Peru declared a state of emergency in the districts of Puerto Inca, Tournavista, Yuyapichis, Codo del Pozuzo and Honoria in the province of Puerto Inca in the department of Huánuco; in the districts of Constitución, Palcazú and Puerto Bermúdez in the province of Oxapampa in the department of Pasco; and in the districts of Raimondi, Sepahua and Tahuanía in the province of Atalaya in the department of Ucayali, for a period of 45 calendar days starting on 5 June 2021.

- Through Supreme Decree No. 133-2021-PCM, dated 16 July 2021, the Government of Peru declared a state of emergency in the districts of Puerto Inca, Tournavista, Yuyapichis, Codo del Pozuzo and Honoria in the province of Puerto Inca in the department of Huánuco; in the districts of Constitución, Palcazú and Puerto Bermúdez in the province of Oxapampa in the department of Pasco; and in the districts of Raimondi, Sepahua and Tahuanía in the province of Atalaya in the department of Ucayali, for a period of 60 calendar days starting on 20 July 2021.
- Through Supreme Decree No. 153-2021-PCM, dated 17 September 2021, the Government of Peru declared a state of emergency in the districts of Puerto Inca, Tournavista, Yuyapichis, Codo del Pozuzo and Honoria in the province of Puerto Inca in the department of Huánuco; in the districts of Constitución, Palcazú and Puerto Bermúdez in the province of Oxapampa in the department of Pasco; and in the districts of Raimondi, Sepahua and Tahuanía in the province of Atalaya in the department of Ucayali, for a period of 60 calendar days starting on 18 September 2021.
- Through Supreme Decree No. 171-2021-PCM, dated 16 November 2021, the Government of Peru declared a state of emergency in the districts of Puerto Inca, Tournavista, Yuyapichis, Codo del Pozuzo and Honoria in the province of Puerto Inca in the department of Huánuco; in the districts of Constitución, Palcazú and Puerto Bermúdez in the province of Oxapampa in the department of Pasco; and in the districts of Raimondi, Sepahua and Tahuanía in the province of Atalaya in the department of Ucayali, for a period of 60 calendar days starting on 17 November 2021.
- Through Supreme Decree No. 004-2022-PCM, dated 15 January 2022, the Government of Peru declared a state of emergency in the districts of Puerto Inca, Tournavista, Yuyapichis, Codo del Pozuzo and Honoria in the province of Puerto Inca in the department of Huánuco; in the districts of Constitución, Palcazú and Puerto Bermúdez in the province of Oxapampa in the department of Pasco; and in the districts of Raimondi, Sepahua and Tahuanía in the province of Atalaya in the department of Ucayali, for a period of 60 calendar days starting on 16 January 2022.
- Through Supreme Decree No. 021-2022-PCM, dated 16 March 2022, the Government of Peru declared a state of emergency in the districts of Puerto Inca, Tournavista, Yuyapichis, Codo del Pozuzo and Honoria in the province of Puerto Inca in the department of Huánuco; in the districts of Constitución, Palcazú and Puerto Bermúdez in the province of Oxapampa in the department of Pasco; and in the districts of Raimondi, Sepahua and Tahuanía in the province of Atalaya in the department of Ucayali, for a period of 60 calendar days starting on 17 March 2022.
- Through Supreme Decree No. 052-2022-PCM, dated 13 May 2022, the Government of Peru declared a state of emergency in the districts of Puerto Inca, Tournavista, Yuyapichis, Codo del Pozuzo and Honoria in the province of Puerto Inca in the department of Huánuco; in the districts of Constitución, Palcazú and Puerto Bermúdez in the province of Oxapampa in the department of Pasco; and in the districts of Raimondi, Sepahua and Tahuanía in the province of Atalaya in the department of Ucayali, for a period of 60 calendar days starting on 17 May 2022.

- Through Supreme Decree No. 020-2023-PCM, dated 9 February 2023, the Government of Peru extended the state of emergency declared in the districts of Puerto Inca, Tournavista, Yuyapichis and Codo del Pozuzo in the province of Puerto Inca in the department of Huánuco; in the districts of Constitución and Puerto Bermúdez in the province of Oxapampa in the department of Pasco; and in the district of Sepahua in the province of Atalaya in the department of Ucayali, for a period of 60 calendar days starting on 10 February 2023.
- The measure was extended to combat more effectively the criminal organizations involved in illicit drug trafficking, illegal mining, kidnapping, extortion and illegal logging in those areas. During the state of emergency, the constitutional rights relating to liberty and security of person, inviolability of the home, and freedom of assembly and movement in the territory, included in articles 9, 12, 17 and 21 of the International Covenant on Civil and Political Rights, are suspended.
