NEW YORK, 16 DECEMBER 1966

PERU: NOTIFICATION UNDER ARTICLE 4 (3) <sup>1</sup>

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

The Permanent Mission of Peru to the United Nations presents its compliments to the Treaty Section of the Office of Legal Affairs, United Nations Secretariat, and, in accordance with article 4 of the International Covenant on Civil and Political Rights, bearing in mind what is stated in note verbale LA 41 TR/2017/IV-4/Peru/1, dated 1 March 2017, has the honour to report the following:

- Through Supreme Decree No. 088-2023-PCM, dated 3 August 2023, the Government of Peru extended the state of emergency for a period of 60 calendar days starting 10 August 2023 until 8 October 2023 in the following districts:

During the state of emergency, the constitutional rights related to liberty and security of person, the inviolability of the home and the freedom of assembly and movement in the territory, included in Articles 9, 12, 17 and 21 of the International Covenant on Civil and Political Rights, are suspended.

The Permanent Mission of Peru to the United Nations takes this opportunity to convey to the Treaty Section of the Office of Legal Affairs, United Nations Secretariat, the renewed assurances of its highest consideration.
