

These Terms and Conditions (“Terms”) set forth the terms and conditions governing your use of the website located at <http://observatory.domains> (the “Website”) owned and operated by Dot Stories SA (a company registered in Switzerland with company number CH-660.2.597.014-5 and registered address at rue du Tir 1bis, 1204 Geneva, Switzerland) and Valideus Limited (a company registered in England and Wales with company number 06181291 and registered office at 28-30 Little Russell Street, London, WC1A 2HN, United Kingdom) (together, “we” or “DOT BRAND OBSERVATORY”), your membership registration and your use of the Content (as defined herein) of and available via the Website.
