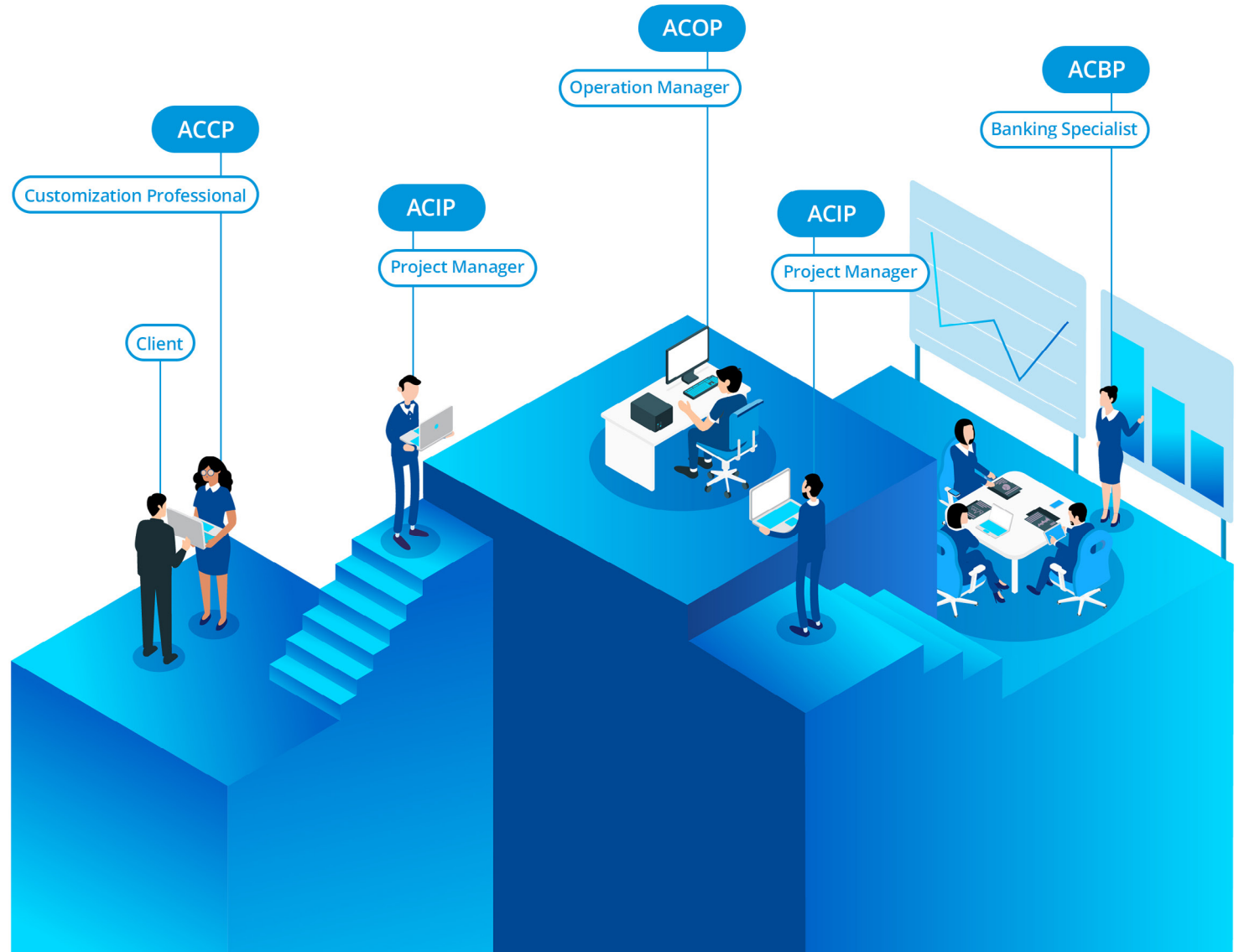

## Accreditation rules

How to renew your certificate



Every certificate is valid for **two years**.



In order to keep your certificate valid, you need to earn **120 accreditation points**.



Accreditation points are earned by completing accreditation courses. 120 points equal **4 course days**.



**Two of the courses must be Delta courses** and the other **two courses can be of your choice**.

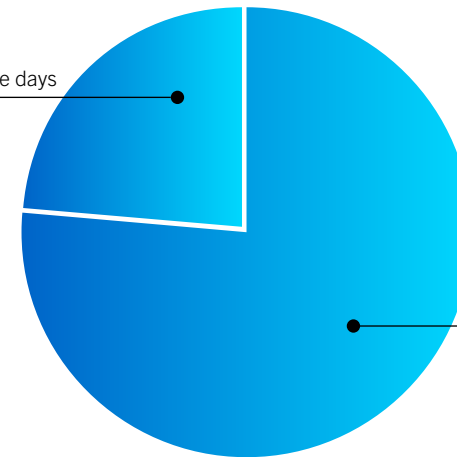

## Validity of certificates

Up until mid-August, issued certificates were only issued to be valid until 31 December 2019. This was done because Academy planned to introduce a new certificate design. This [new design is now gradually being rolled out](#).

In Q4 2019, everyone who has both a valid certificate and is eligible for certificate renewal will receive a new certificate with the new design. This certificate will be [valid from 1 January 2020 until the remainder of the two years](#).
