A BILL

To authorize the President to award a gold medal on behalf

of the Congress to Father Theodore M. Hesburgh, in recognition of his outstanding and enduring contributions to civil rights, higher education, the Catholic Church, the Nation, and the global community.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Father Theodore M.5 Hesburgh Congressional Gold Medal Act".

6 SEC. 2. FINDINGS.

7 The Congress finds that—

8 (1) Father Theodore M. Hesburgh, C.S.C., has 9 made outstanding and enduring contributions to 10 American society through his activities in civil 11 rights, higher education, the Catholic Church, the 12 Nation, and the global community;

(2) Father Hesburgh was a charter member of
the United States Commission on Civil Rights from
its creation in 1957 and served as chairperson of the
Commission from 1969 to 1972;

17 (3) Father Hesburgh was president of the Uni18 versity of Notre Dame from 1952 until 1987, and
19 has been president emeritus since 1987;

20 (4) Father Hesburgh is a national and inter-21 national leader in higher education;

1	(5) Father Hesburgh has been honored with the
2	Elizabeth Ann Seton Award from the National
3	Catholic Education Association and with more than
4	130 honorary degrees;
5	(6) Father Hesburgh served as co-chairperson
6	of the nationally influential Knight Commission on
7	Intercollegiate Athletics and as chairperson, from
8	1994 to 1996, of the Board of Overseers of Harvard
9	University;
10	(7) Father Hesburgh served under President
11	Ford as a member of the Presidential Clemency
12	Board, charged with deciding the fates of persons
13	committing offenses during the Vietnam conflict;
14	(8) Father Hesburgh served as chairman of the
15	board of the Overseas Development Council and in
16	that capacity led fundraising efforts that averted
17	mass starvation in Cambodia in 1979 and 1980;
18	(9) Father Hesburgh served from 1979 to 1981
19	as chairperson of the Select Commission on Immi-
20	gration and Refugee Policy, which made rec-
21	ommendations that served as the basis of congres-
22	sional reform legislation enacted 5 years later;
23	(10) Father Hesburgh served as ambassador to
24	the 1979 United Nations Conference on Science and
25	Technology for Development; and

(11) Father Hesburgh has served the Catholic
 Church in a variety of capacities, including his serv ice from 1956 to 1970 as the permanent Vatican
 representative to the International Atomic Energy
 Agency in Vienna and his service as a member of
 the Holy See's delegation to the United Nations.

7 SEC. 3. CONGRESSIONAL GOLD MEDAL.

8 (a) PRESENTATION AUTHORIZED.—The President is 9 authorized to present, on behalf of the Congress, a gold 10 medal of appropriate design to Father Theodore M. 11 Hesburgh in recognition of his outstanding and enduring 12 contributions to civil rights, higher education, the Catholic 13 Church, the Nation, and the global community.

(b) DESIGN AND STRIKING.—For purposes of the
presentation referred to in subsection (a), the Secretary
of the Treasury (in this Act referred to as the "Secretary") shall strike a gold medal with suitable emblems,
devices, and inscriptions, to be determined by the Secretary.

20 SEC. 4. DUPLICATE MEDALS.

The Secretary may strike and sell duplicates in bronze of the gold medal struck pursuant to section 3 under such regulations as the Secretary may prescribe, at a price sufficient to cover the cost thereof, including labor, materials, dies, use of machinery, and overhead expenses,
 and the cost of the gold medal.

3 SEC. 5. NATIONAL MEDALS.

4 The medals struck pursuant to this Act are national
5 medals for purposes of chapter 51 of title 31, United
6 States Code.

7 SEC. 6. AUTHORIZATION OF APPROPRIATIONS; PROCEEDS 8 OF SALE.

9 (a) AUTHORIZATION OF APPROPRIATIONS.—There is
10 authorized to be charged against the Numismatic Public
11 Enterprise Fund an amount not to exceed \$30,000 to pay
12 for the cost of the medal authorized by this Act.

(b) PROCEEDS OF SALE.—Amounts received from the
sales of duplicate bronze medals under section 4 shall be
deposited in the Numismatic Public Enterprise Fund.
