To make technical corrections in copyright law.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Copyright Technical
3 Corrections Act of 2000”.

4 **SEC. 2. CORRECTIONS TO 1999 ACT.**

5 Title I of the Intellectual Property and Communica-
6 tions Omnibus Reform Act of 1999, as enacted by section
7 1000(a)(9) of Public Law 106–113, is amended as follows:

8 (1) Section 1007 is amended—

9 (A) in paragraph (2), by striking “para-
10 graph (2)” and inserting “paragraph (2)(A)”;
11 and

12 (B) in paragraph (3), by striking
13 “1005(e)” and inserting “1005(d)”.

14 (2) Section 1006(b) is amended by striking
15 “119(b)(1)(B)(iii)” and inserting
16 “119(b)(1)(B)(ii)”.

17 (3)(A) Section 1006(a) is amended—

18 (i) in paragraph (1), by adding “and”
19 after the semicolon;

20 (ii) by striking paragraph (2); and

21 (iii) by redesignating paragraph (3) as
22 paragraph (2).

23 (B) Section 1011(b)(2)(A) is amended to read
24 as follows:

25 “(A) in paragraph (1), by striking ‘pri-
26 mary transmission made by a superstation and

1 embodying a performance or display of a work’
2 and inserting ‘performance or display of a work
3 embodied in a primary transmission made by a
4 superstation or by the Public Broadcasting
5 Service satellite feed’;”.

6 **SEC. 3. AMENDMENTS TO TITLE 17, UNITED STATES CODE.**

7 Title 17, United States Code, is amended as follows:

8 (1) Section 119(a)(6) is amended by striking
9 “of performance” and inserting “of a performance”.

10 (2)(A) The section heading for section 122 is
11 amended by striking “**rights; secondary**” and
12 inserting “**rights: Secondary**”.

13 (B) The item relating to section 122 in the
14 table of contents for chapter 1 is amended to read
15 as follows:

“122. Limitations on exclusive rights: Secondary transmissions by satellite car-
riers within local markets.”.

16 (3)(A) The section heading for section 121 is
17 amended by striking “**reproduction**” and insert-
18 ing “**Reproduction**”.

19 (B) The item relating to section 121 in the
20 table of contents for chapter 1 is amended by strik-
21 ing “reproduction” and inserting “Reproduction”.

22 (4)(A) Section 106 is amended by striking “107
23 through 121” and inserting “107 through 122”.

1 (B) Section 501(a) is amended by striking “106
2 through 121” and inserting “106 through 122”.

3 (C) Section 511(a) is amended by striking “106
4 through 121” and inserting “106 through 122”.

5 (5) Section 101 is amended—

6 (A) by moving the definition of “computer
7 program” so that it appears after the definition
8 of “compilation”; and

9 (B) by moving the definition of “registra-
10 tion” so that it appears after the definition of
11 “publicly”.

12 (6) Section 110(4)(B) is amended in the matter
13 preceding clause (i) by striking “conditions;” and in-
14 serting “conditions:”.

15 (7) Section 118(b)(1) is amended in the second
16 sentence by striking “to it”.

17 (8) Section 119(b)(1)(A) is amended—

18 (A) by striking “transmitted” and insert-
19 ing “retransmitted”; and

20 (B) by striking “transmissions” and insert-
21 ing “retransmissions”.

22 (9) Section 203(a)(2) is amended—

23 (A) in subparagraph (A)—

24 (i) by striking “(A) the” and inserting
25 “(A) The”; and

1 (ii) by striking the semicolon at the
2 end and inserting a period;

3 (B) in subparagraph (B)—

4 (i) by striking “(B) the” and inserting
5 “(B) The”; and

6 (ii) by striking the semicolon at the
7 end and inserting a period; and

8 (C) in subparagraph (C), by striking “(C)
9 the” and inserting “(C) The”.

10 (10) Section 304(c)(2) is amended—

11 (A) in subparagraph (A)—

12 (i) by striking “(A) the” and inserting
13 “(A) The”; and

14 (ii) by striking the semicolon at the
15 end and inserting a period;

16 (B) in subparagraph (B)—

17 (i) by striking “(B) the” and inserting
18 “(B) The”; and

19 (ii) by striking the semicolon at the
20 end and inserting a period; and

21 (C) in subparagraph (C), by striking “(C)
22 the” and inserting “(C) The”.

23 (11) The item relating to section 903 in the
24 table of contents for chapter 9 is amended by strik-
25 ing “licensure” and inserting “licensing”.

1 **SEC. 4. OTHER AMENDMENTS.**

2 (a) AMENDMENT TO TITLE 18.—Section 2319(e)(2)
3 of title 18, United States Code, is amended by striking
4 “107 through 120” and inserting “107 through 122”.

5 (b) STANDARD REFERENCE DATA.—(1) Section
6 105(f) of Public Law 94–553 is amended by striking “sec-
7 tion 290(e) of title 15” and inserting “section 6 of the
8 Standard Reference Data Act (15 U.S.C. 290e)”.

9 (2) Section 6(a) of the Standard Reference Data Act
10 (15 U.S.C. 290e) is amended by striking “Notwith-
11 standing” and all that follows through “United States
12 Code,” and inserting “Notwithstanding the limitations
13 under section 105 of title 17, United States Code,”.
