A BILL

To amend title 35, United States Code, to promote research among universities, the public sector, and private enterprise.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “Cooperative Research*
3 *and Technology Enhancement (CREATE) Act of 2004”.*

4 **SEC. 2. COLLABORATIVE EFFORTS ON CLAIMED INVEN-**
5 **TIONS.**

6 *Section 103(c) of title 35, United States Code, is*
7 *amended to read as follows:*

8 *“(c)(1) Subject matter developed by another person,*
9 *which qualifies as prior art only under one or more of sub-*
10 *sections (e), (f), and (g) of section 102 of this title, shall*
11 *not preclude patentability under this section where the sub-*
12 *ject matter and the claimed invention were, at the time the*
13 *claimed invention was made, owned by the same person or*
14 *subject to an obligation of assignment to the same person.*

15 *“(2) For purposes of this subsection, subject matter de-*
16 *veloped by another person and a claimed invention shall*
17 *be deemed to have been owned by the same person or subject*
18 *to an obligation of assignment to the same person if—*

19 *“(A) the claimed invention was made by or on*
20 *behalf of parties to a joint research agreement that*
21 *was in effect on or before the date the claimed inven-*
22 *tion was made;*

23 *“(B) the claimed invention was made as a result*
24 *of activities undertaken within the scope of the joint*
25 *research agreement; and*

1 “(C) *the application for patent for the claimed*
2 *invention discloses or is amended to disclose the*
3 *names of the parties to the joint research agreement.*

4 “(3) *For purposes of paragraph (2), the term ‘joint*
5 *research agreement’ means a written contract, grant, or co-*
6 *operative agreement entered into by two or more persons*
7 *or entities for the performance of experimental, develop-*
8 *mental, or research work in the field of the claimed inven-*
9 *tion.’.*”

10 **SEC. 3. EFFECTIVE DATE.**

11 (a) *IN GENERAL.*—*The amendments made by this Act*
12 *shall apply to any patent granted on or after the date of*
13 *the enactment of this Act.*

14 (b) *SPECIAL RULE.*—*The amendments made by this*
15 *Act shall not affect any final decision of a court or the*
16 *United States Patent and Trademark Office rendered before*
17 *the date of the enactment of this Act, and shall not affect*
18 *the right of any party in any action pending before the*
19 *United States Patent and Trademark Office or a court on*
20 *the date of the enactment of this Act to have that party’s*
21 *rights determined on the basis of the provisions of title 35,*
22 *United States Code, in effect on the day before the date of*
23 *the enactment of this Act.*

Amend the title so as to read: “A bill to amend title 35, United States Code, to promote cooperative research

involving universities, the public sector, and private enterprises.”.
