A BILL

To provide certain counties with the ability to receive television broadcast signals of their choice.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Four Corners Tele-
- 5 vision Access Act of 2009".
- 6 SEC. 2. SATELLITE CARRIAGE OF CERTAIN TELEVISION
- 7 BROADCAST SIGNALS.
- 8 Section 119(a)(2)(C)(iv) of title 17, United States
- 9 Code, is amended—

1	(1) by redesignating subclauses (I) and (II) as
2	items (aa) and (bb) and inserting "(I)" before
3	"(aa)"; and
4	(2) in item (bb), as so redesignated by para-
5	graph (1), after "Nielsen Media Research" insert
6	the following: "; or
7	" $(II)(aa)$ the 2 counties are lo-
8	cated in the 46th largest designated
9	market area for the year 2005 accord-
10	ing to Nielsen Media Research; and
11	"(bb) the total number of tele-
12	vision households in the 2 counties
13	combined did not exceed 30,000 for
14	the year 2005 according to Nielsen
15	Media Research''.
16	SEC. 3. CABLE CARRIAGE OF CERTAIN TELEVISION BROAD-
17	CAST SIGNAL.
18	Section 341 of Communications Act of 1934 (47
19	U.S.C. 341) is amended by adding at the end the fol-
20	lowing:
21	"(c) Rule of Construction.—
22	"(1) Significantly viewed.—Each television
23	broadcast station broadcasting in the designated
24	market area of a State capital is deemed signifi-
25	cantly viewed within the meaning of section 76.54 of

- title 47, Code of Federal Regulations, for purposes
 of the carriage and retransmission of the signals of
 such broadcast station by a cable system, translator,
 or other multichannel video programming distributor.
 - "(2) Retransmission permitted.—Notwithstanding the provisions of section 325(b), a cable system, translator, or other multichannel video programming distributor may retransmit the signal of any television broadcast station described in paragraph (1) within a covered county.
 - "(3) Definition of Covered County.—For purposes of this subsection, a county is a covered county if—
 - "(A) it is 1 of 2 counties located in the 46th largest designated market area for the year 2005 according to Nielsen Media Research; and
 - "(B) the total number of television households in the 2 counties combined did not exceed 30,000 for the year 2005 according to Nielsen Media Research.".
