**SECONDARY TRANSMISSION SERVICE: SUBSCRIBERS AND RATES**

**PRIMARY TRANSMITTERS: TELEVISION**

**Column 3:** Indicate in each case whether the station is a network station, an independent station, or a noncommercial educational station, by entering the letter "N" (for network), "N-M" (for network multicast), "I" (for independent), "I-M" (for independent multicast), "E" (for noncommercial educational), or "E-M" (for noncommercial educational multicast). For the meaning of these terms, see page (iv) of the general instructions.
