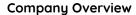

Foreign Ownership Limitations covers the limits on the amount a foreign firm or individual can invest in a business in another country through buying shares. This information is used by index providers in determining the "free float".

Direct holding ratio by foreigners

The foreign investors' holding ratio is ratio in between the total number of stocks held by the foreigners and total number of outstanding shares issued by the company.

Upper limit on foreign investment

Upper limit on foreign investment is the maximum investment level allowed by the government to the foreign person/company.




