Worldwide End-of-Day Prices - Equities, Bonds and Indices

Mark-to-market your positions and settle transactions on a timely basis

The closing price is considered the most up-to-date, standardized valuation of a security until trading commences again on the next trading day. This data is used for portfolio valuation, index calculation, technical analysis and benchmarking throughout the financial industry.

The End-of-Day Pricing service covers equities, equity derivative bonds, and indices listed on 170 markets worldwide.

Obtain fast access to accurate closing pricing data

The closing price feed comprises a set of daily exchange price files for EMEA (Europe, Middle East, and Africa), Asia/Pacific and the Americas. Data elements include:

Additionally, to the official confirmed prices, the pricing service also provides unconfirmed prices for all the major markets as well as adjustment factors.

Please note: Clients that purchase EOD pricing files should note that there is a repush file that requires to be continuously processed (this file picks up any prices that EDI flagged for a high % change from the previous close). This file overwrites the previous file.

Adjusted Pricing Data

Compare historical pricing data with current prices and conduct detailed analysis.

- Ready to use adjusted closing pricing file
- Load adjusted closing price data onto your system directly, without having to worry about applying the adjustment factors

Stocks are only included in the adjusted prices feed when an event has an impact.

This impact must generate an adjustment factor greater than 0 and less than 0.95 and greater than 1.05, so a stock with a factor of 0.98 will not be included in the feed. This has the effect of eliminating most stocks having minor dividend events from the feed. However, when a stock is included in the feed, only events with a factor greater than 0 and less than 0.95 and greater 1.05 will be applied.

If users have specific requirements, as EDI cannot customize the feed for individual clients, they recommend the unadjusted prices and adjustment factors feed and build their desired database.

EDI applies multiple filters to ensure the accuracy of exchange prices. In cases of uncertainty regarding the price's accuracy, we "quarantine" it (delete it from the price file) before releasing the price file whilst we seek confirmation from the exchange. Upon correction or validation of the price's accuracy by the exchange, we add it back into the original file with a "Repush" message in the comment section of the price record and then incorporate the edited price file into a supplementary feed.

Adjustment factors

Have full control over events or factors for which you adjust and perform your own historical adjustments.

Adjustment factors in conjunction with unadjusted prices can be used to build a database of adjusted prices according to your criteria, giving you the ability to compare prices over different date points.

Alternatively, they can be used to back adjust different price series, e.g. dividends or EPS, etc.so meaningful comparisons can be made.

Feed Specifications

End-of-Day Price Files

EDI's End of Day Pricing feed is delivered by SFTP connection, Dropbox or Amazon S3. Clients have a choice between receiving price files stored in folders named using the ISO country code, which contain the last 20 days of data, and receiving one folder with all price files, containing data of the last 6 days.

EDI executes a precise strategy to validate price adjustments within our end-of-day pricing files. We temporarily withhold high percentage price changes to confirm accuracy. Subsequently, we issue a re-push file to ensure inclusion of securities held for price movement validation.

Notes on the Lookups

Combined lookup table where codes of a particular type are grouped by TypeGroup.

Join using the Typegroup of the coded field data and the coded data field content to get the lookup. Only field containing coded date has the Typegroup column populated.



This table also gives all the POSSIBLE VALUES.

Because it is combining multiple coded types, the format of the field must accommodate the largest possible code in the whole system hence the slight apparent incompatibility in length between joining fields.
