National Veterans Legal Services Program with Capital One and MFA Financial

Hunton Andrews Kurth attorneys have partnered with Capital One and MFA Financial on direct representation Combat-Related Special Compensation matters. Jamie Isani (Miami) worked on a Combat-Related Special Compensation (CRSC) matter in partnership with Capital One. The veteran, an Army Special Forces Engineer Sergeant, was awarded the Combat Infantryman Badge for his bravery in combat in Afghanistan. He suffered traumatic brain injury with PTSD, migraines and retinal detachment as a result of numerous training incidents and extensive exposure to blasts in combat theaters. He also suffered rhinitis, a condition that is presumptively serviceconnected due to burn pit exposure in the Gulf War. Jamie and the Capital One attorney worked together to interview the client, draft portions of the legal brief and prepare the factual record from military and medical records, ultimately obtaining an award of CRSC for all of the conditions the veteran was seeking. Brian Otero (New York) and Patrick Macher (Charlotte) also are partnering with a lawyer from MFA Financial to assist a veteran on a Combat-Related Special Compensation (CRSC) matter

Mid-Atlantic Innocence Project Screening Committee with Corporate Clients

This past fiscal year, Hunton Andrews Kurth volunteers dedicated over 1,300 hours to reading and screening files from prisoners who are seeking assistance from the Mid-Atlantic Innocence Project (MAIP). Central Virginia Legal Aid Society and CarMax

Mike Goldman (Richmond) and Claire Frost (CarMax) co-chaired an Eviction Expungement Pilot through Central Virginia Legal Aid Society (CVLAS). Through a new law passed in 2022, many Virginia tenants are eligible for expungement of their eviction records if the suit was dismissed/nonsuited. In November 2022, Mike, Claire and Christina Edwards (Richmond) filed 46 expungement petitions on behalf of 16 clients. The law requires that the records be expunged upon receiving the petition, so with just a few hours of work, the team enabled the tenants to position themselves for better housing opportunities in the future.

Legal Lines with bp

Lawyers from the firm's Houston office partnered with bp to sponsor a LegalLine lunch event through Houston Volunteer Lawyers (HVL). LegalLine is a weekly opportunity for individuals seeking civil legal help to receive legal advice from pro bono attorneys. Thirty lawyers between the two organizations worked in pairs to assist 2-3 pro bono clients per team.

GRBF Wills Clinic with AUB

Tara Elgie (Dallas), Sandy Collins and Jess Tobin (Richmond) partnered with lawyers from Atlantic Union Bank and law students from the University of Richmond School of Law to volunteer at a Wills Clinic that the firm sponsored through the Greater Richmond Bar Foundation. Through the clinic, volunteers assisted low-income individuals with basic life planning documents, such as a basic will, Power of Attorney and/or Advance Medical Directives.
