## HEALTH ACT 1947 (FIXED PAYMENT NOTICE AND DWELLING EVENT PROVISIONS) (COVID-19) (AMENDMENT) (NO. 2) REGULATIONS 2020

- I, STEPHEN DONNELLY, Minister for Health, in exercise of the powers conferred on me by sections 5, 31A and 31C (inserted by section 4 of the Health (Amendment) Act 2020 (No. 19 of 2020)) of the Health Act 1947 (No. 28 of 1947) and -
  - (a) having regard to the immediate, exceptional and manifest risk posed to human life and public health by the spread of Covid-19 and to the matters specified in section 31A(2) of that Act,
  - (b) having regard also to the matters specified in section 31A(6C)(b) of that Act, and
  - (c) having consulted with the Minister for Justice,

hereby make the following regulations:

- 1. (1) These Regulations may be cited as the Health Act 1947 (Fixed Payment Notice and Dwelling Event Provisions) (Covid-19) (Amendment) (No. 2) Regulations 2020.
- (2) These Regulations shall come into operation on the 18<sup>th</sup> day of December 2020.
- 2. The Health Act 1947 (Fixed Payment Notice and Dwelling Event Provisions) (Covid -19) Regulations 2020 (S.I. No. 536 of 2020) are amended in Schedule 1, by the insertion of the following paragraphs after paragraph 6:
