I am pleased to invite you to participate in the 2024 Global Symposium for Regulators (GSR-24) under the theme: *Regulation for impact.* GSR-24 will be organized by the International Telecommunication Union (ITU), in collaboration with the Government of Uganda. The event will be held from 1-4 July 2024 at the Speke Resort and Conference Centre Munyonyo, Uganda and be chaired by Mr George William Nyombi Thembo, Executive Director of the Uganda Communications Commission (UCC).

They include maximizing digital opportunities with a focus on financing and collaborative regulatory approaches; space economy; connecting everyone, everything, everywhere, all at once; mastering digital transformation; Artificial Intelligence (AI) and robotics for positive impact; safe and inclusive digital financial services; regulatory sandboxing for innovation; harnessing digital for climate action.
