Background

On 28 September, the Office of the Australian Information Commissioner (OAIC) will join members of the United Nations and Australian states and territories in marking **International Access to Information Day**.

This global event celebrates and recognises the importance of the community's right to know and to access information from governments around the globe.

In October 2019, the 74th United Nations General Assembly proclaimed 28 September as the International Day for Universal Access to Information (IDUAI).

Our right to access Australian Government information is enshrined in the *Freedom of Information Act 1982* (FOI Act) which recognises that government-held information is a national resource that should be managed for public purposes.

This year's theme chosen by UNESCO is the importance of the online space for access to information.

We encourage Australian Government agencies to mark International Access to Information Day with us, by showing support for enhancing the community's ability to access government-held information. The online space is critical to this, and we must be mindful of barriers preventing people exercising their rights to access information, and support digital inclusion in all aspects of information access.

Access to Information Day also provides an important opportunity to acknowledge the crucial role of your agency's FOI practitioners and decision-makers and their work in managing government-held information as a national resource.

We also hold ICON information sessions to share news about our activities and discuss areas of interest such as FOI processing, Information Commissioner reviews and the Information Publication Scheme.



Dear colleagues

International Access to Information Day (IAID) is approaching on Thursday 28 September, with this year's theme, <u>selected by UNESCO</u>, being the importance of the online space for access to information.

IAID recognises the importance of the community's right to access information from governments around the globe. It is an opportunity to acknowledge and reflect on the role of government in promoting transparency and accountability, and to recognise the important work of FOI teams.

This year's theme reminds us of the importance of digital inclusion in supporting people's access to information, in an increasingly online world.

One of the principles of IAID is that government-held information is a national resource to be shared with citizens, unless there is an overriding reason not to do so. In thinking about making information available, and accessible, we must be mindful of barriers preventing people exercising their rights to access information, and support digital inclusion in all aspects of information access.

In Australia, our *Freedom of Information Act 1982* is intended to support our democracy by increasing scrutiny and review of government activities and public participation in government processes.

The work of our FOI team and officers across our agency is essential, not only upholding our FOI laws and managing information as a national resource, but in creating a culture of openness by design.

This International Access to Information Day, we are joining with the Office of the Australian Information Commissioner (OAIC) in supporting the value of access to government-held information and its role in helping all Australians participate in our democracy.
