- 1. The following amendment to the Greene County Rules of Procedure (G.Co.R.) is adopted as a Rule of this Court, effective September 1, 2003 or thirty (30) days after publication in the *Pennsylvania Bulletin*, whichever is later.
 - 2. The Court Administrator of Greene County shall:
- (a) File ten (10) certified copies of this Order and the following Rule with the Administrative Office of Pennsylvania Courts;
- (b) Distribute two (2) certified copies of this Order and the following Rule to the Legislative Reference Bureau for publication in the *Pennsylvania Bulletin*.
- (c) File one (1) certified copy of this Order and the following Rule with the Pennsylvania Civil Procedure Rules Committee;
- (d) File proof of compliance with this order in the docket at the above number and term, which shall include a copy of each letter of transmittal; and
- (e) Cause a copy of this Order and the attached Rule to be published one (1) time in the *Greene Reports*.

It is further *Ordered* that on the effective date of the following local rule, all previous local rules shall remain in effect.

Local Rule G1915.1. Seminar for Separating or Divorcing Parents

All parties to Custody Actions filed on or after September 1, 2003, where the interests of children under the age of eighteen (18) years are involved, shall, unless excused by the Court, complete a program entitled the Seminar for Separating or Divorcing Parents (the "Seminar").

All parties shall register for the first available Seminar after the date the defendant has been served with process. Counsel for the plaintiff shall require the plaintiff to register for the Seminar and shall have a copy of the attached Notice and Registration Form served on the defendant at the same time as the Complaint.

Failure of a party to successfully complete the Seminar will result in sanctions by the Court, including contempt.

Every Complaint in Custody shall set forth in a separate attached statement, the names, addresses and telephone numbers of the parties, and the names and ages of all children under the age of eighteen (18) years. This Rule shall become effective September 1, 2003 or not

less than thirty (30) days after the date of publication in the *Pennsylvania Bulletin*.

NOTICE TO ATTEND

All parents of children under 18 years of age and who are involved in child custody or divorce litigation are required by the Greene County Court to attend an educational seminar. The seminar deals with the subject of how children cope with separation and divorce. Failure to complete the seminar will result in appropriate sanctions by the Court.

This seminar is a four hour program presented by qualified counselors under a contract with the Court. Catholic Charities is licensed to conduct this seminar which is a copyrighted program and which has no religious content and is not in any way controlled by the Catholic Church. It is held in the Catholic Charities Office, 95 East High Street, Room 107, Waynesburg, Pennsylvania. Parents need not attend the same session and children are NOT to be brought.

It Is Further Ordered that the following individuals are appointed and approved as custody mediators, under Pa.R.Civ.P. § 1940.4, for the term of 2003 and until further Order:

Any individual approved as a mediator or any mediator approved as a custody mediation supervisor shall remain in compliance with any and all rules and regulations of the Commonwealth of Pennsylvania, and shall only mediate custody cases in conformity with procedures and duties set forth under Pa.R.Civ.P. § 1940.1—1940.9.

The appointment of Marilyn Anita Vestal, MBA, Ph.D. is conditioned upon her strict compliance with Pa.R.Civ.P. § 1940.4(a)(4), requiring additional mediation training consisting of a minimum of 4 mediated cases totaling 10 hours under the supervision of one of the listed mediation supervisors.

- It Is Further Ordered that, in accordance with Pa.R.Civ.P. § 239, the District Court Administrator shall:
- (a) File seven copies hereof with the Administrative Office of Pennsylvania Courts;
- (b) Distribute two certified copies hereof to the Legislative Reference Bureau for Publication in the *Pennsylvania Bulletin*;
- (c) File one certified copy hereof with the Domestic Relations Procedural Rules Committee;
- (d) Cause a copy hereof to be published in the *York Legal Record* at the expense of the County of York; and
- (e) Supervise the distribution hereof to all Judges, the mediators appointed, and to the custody conciliators.
