# **Media Advisory**

#### WHAT:

The United Nations Office of Counter-Terrorism will hold a Virtual Counter-Terrorism Week from 6 to 10 July 2020, under the overarching theme of "Strategic and Practical Challenges of Countering-Terrorism in a Global Pandemic Environment".

Through strategic and expert-level online discussions, the participants will exchange views on what the new circumstances created by the COVID-19 pandemic mean for the counter-terrorism landscape. This event provides an opportunity for a collective reflection among the Member States, United Nations entities, civil society organizations, the private sector and other stakeholders, on the implications of the COVID-19 crisis on Member States' counter-terrorism priorities and the United Nations' work to support them tackling this scourge.

The Virtual Counter-Terrorism Week is composed of a total of ten webinars and interactive discussions focusing on: bio and cyber terrorism, high-risk threats and trends, addressing the plight of victims of terrorism, flagship UN counter-terrorism programmes, human rights and counter-terrorism, countering the financing of terrorism, youth-led initiatives to build resilient societies, and the role of civil society and media in preventing violent extremism conducive to terrorism and countering terrorism.

The Opening Webinar, the UNCCT Expo and the Closing Discussion will be open to media and streamed on UN WebTV. The rest are by invitation only.

### **BACKGROUND:**

Just as we commemorate the 75th Anniversary of the United Nations and reflect on the "world we want and the United Nations we need," the COVID-19 pandemic is presenting the international community with possibly the worst crisis since the Second World War. United Nations Secretary-General António Guterres has called this a "human crisis" that has attacked societies at the core, killing people and upending lives.

In these unprecedented and unpredictable times, we are yet to fully grasp the implications of the COVID-19 crisis for national, regional and international efforts to prevent and counter terrorism. Amid the suffering and disruption generated by the virus, terrorists have sought to exploit the pandemic to validate their narratives, foster hate and division, inspire and recruit followers, and launch new attacks. The pandemic and its fallout are exacerbating socioeconomic and political challenges recognized by the General Assembly as conducive to the spread of terrorism. It has exposed vulnerabilities to new and emerging forms and manifestations of terrorism, such as bio and cyber terrorism.

The Virtual Counter-Terrorism Week, which will be held from 6 to 10 July 2020, under the overarching theme of "Strategic and Practical Challenges of Countering-Terrorism in a Global Pandemic Environment", will aim to address these and other related issues through webinars and interactive discussions with UN Member States, UN entities, international and regional organizations, civil society organizations and the private sector, among other stakeholders.
