# MEDIA ARRANGEMENTS FOR UNGA78

- Delegations: Request media passes for journalists and **official photo/video** via eRegistration **by 8 September** ([instructions](#)). Media have green **P** on their pass. Deadline for media applying on their own is 1 September
- Designated entrance for media pass holders: 1<sup>st</sup> Ave. at 47<sup>th</sup> St. (**Delegate with “press attache” secondary card may also enter here**)
- “Press Attache” secondary card (2): Delegate (Red D) can escort **5** media to bilateral booths in GA Building (access from GA plaza). **Please stay with media and exit together from restricted area**
- Media Centre on North Lawn – workspace and live video feeds (**please bring cables**)
