- Qualify and test VAP partner solutions and document specific configuration settings during testing
- Assure customers that VAP partner solutions meet a set of operational standards with Veeam products.

Categories of Veeam Ready

Veeam Ready qualifies storage solutions that customers may consider as a backup target for applications protected by Veeam Backup & Replication. Currently, there are four Veeam Ready categories, each with unique testing requirements:



Veeam Ready — Repository

VAP Partners with primary backup storage solutions may qualify as Veeam Ready — Repository by meeting or exceeding functional and performance tests for backup and restore operations





Veeam Ready — Object

VAP Partners with S3-compatible object storage solutions may qualify as Veeam Ready — Object by verifying compatibility with Veeam Backup & Replication object storage capabilities

Veeam Ready — Tape

VAP Partners with offline storage solutions may qualify as Veeam Ready — Tape by verifying compatibility with Veeam Backup & Replication tape features and operations
