The European Community and its Member States Proposal

In the view of the European Community and its Member States, the following modifications in Article 4 and Article 11 of the Basic Proposal for the Substantive Provisions are required, should the present structure of Article 11 be retained. It is without prejudice to the final outcome of the discussions on Article 11 and subject to further deliberations on this provision.

1. Article4andagreedstatement

Article4 NationalTreatment

- (1) EachContract ingPartyshallaccordtonationalsofotherContractingPartiesthe treatmentitaccordstoitsownnationalswithregardtotheexclusiverightsspecifically grantedinthis AgrrementandtherighttoequitableremunerationprovidedforinArticle11of thisAgreement.
- (2) A Contracting Party shall be entitled, in respect of nationals of another Contracting Party, to limit the protection provided for in paragraph (1) with respect of the rights provided for in Article 11 (1) and 11 (2) of this Agreement to the extent to which, and to the term for which, the latter Contracting Party grants such rights to the national soft he former Contracting Party.
- $(3) \quad The obligation provided for in paragraph (1) does not apply to the extent that a Contracting Partymakes use of the reservations permitted by Article 11 (3) of this Agreement.$

AgreedstatementconcerningArticle4: When making the comparison in Article 4(2) between the Contracting Parties concerned, the material equivalence of the right in question effectively applied for the benefit of the performers hould be considered.
